Changes to the interior of any building or tenant space require Zoning Approval, and may require Building Permits. Prepare and submit a floor plan which indicates changes to be made to the interior of the building.

Exterior Modifications

Any proposed change to the exterior of a building or tenant space will require property owner approval, as well as the Village's review & approval PRIOR to initiating the change; Building Permits may also be required. Submit elevations and building plans along with this application to initiate a preliminary review.
